RE: Performance Inspection of the Onsite Sewerage System at 277 Mansell Road, Salt Spring Island, B.C.

Dear Ms Sabrina Port

I attended on July 8, 2013 to carry out an inspection of the onsite sewerage system serving this home noted above.

A performance inspection was carried out todetermine the size, condition and overall performance of the system.

During the **performance inspection** the following items were noted:

Tank Location

- Location of septic tank isapproximately 20 feet from the home.
- The septic tank lids are 8 inches below ground level under wooden covers.

Operating System

- Septic tank is a 600gallon 2 compartment, Dan's precast concrete tank.
- The 600 gallon tank is of proper size for the daily flow rates from this residence when it was installed.
- The outlet lid was removed to inspect the tank's interior. The tankis in good condition and will need to be pumped out soon.
- An effluent filter was found in the outlet "T". This is to help prevent solids from entering the distribution box. The effluent level was high in the septic tank due to the filter being plugged. It was cleaned at time of Inspection.
- The pump chamber is in good condition and the pump is working properly.
- The absorption field was located approximately 115 feet from the septic tank uphill from the homeand the 3 runs of infiltrators are 6 inches below ground level at approximately 45 feet each in length.
- The upper infiltrator was exposed in two locations to inspect the soil at the bottom of the infiltrator and the interior of the infiltrator. It is in good condition.

Recommendations

- The septic tank lids should be left accessible to aid in the servicing of the effluent filter located in the outlet "T". This filter should be cleaned at least once per year.
- Septic tank should be pumped out soon and then again every 3-5 years, or as needed.
